

Centrelink Income Consent Form

PLEASE READ THIS FIRST

If you are aged 18 years and over and receive a pension, allowance or payment from Centrelink you can complete and sign this consent form to allow Wentworth Community Housing (Wentworth) to obtain your income details from Centrelink.

This consent will allow Centrelink to provide electronically to Wentworth full details of your income and assets so that Wentworth can assess:

- Your entitlement to a rental subsidy and / or
- Your ongoing eligibility for social housing

Wentworth will assess your income and asset details and determine your eligibility for a rental subsidy based on the NSW Community Housing Rent Policy. Wentworth will assess your eligibility for social housing based on Housing NSW's Public Housing Eligibility policy.

If you are not the tenant or main applicant, please be aware that your income and asset information maybe disclosed to the tenant or main applicant to ensure the ongoing eligibility for a rental subsidy or social housing eligibility.

When completing this form it is important that you make sure you have completed your full name, date of birth, Centrelink reference number and that you have signed the consent form in the box provided.

Consent Statement

I hereby authorise:

- Wentworth Community Housing Ltd to use Centrelink Confirmation eServices to perform a Centrelink enquiry of my Centrelink Customer details in order to enable Wentworth Community Housing Ltd to determine if I qualify for a rebate/service.
- The Australian Government Department of Human Services (the department) to provide the results of that enquiry to Wentworth Community Housing Ltd.

I understand that:

- The department will use information I have provided to Wentworth Community Housing Ltd to confirm my eligibility for a rebate/service and will disclose to Wentworth Community Housing Ltd personal information, current or historical, including my name, address, payment type, payment status, income, assets, one-off payments, deductions and shared care arrangements.
- This consent, once signed, remains valid while I am a customer of Wentworth Community Housing Ltd unless I withdraw it by giving notice in writing to Wentworth Community Housing Ltd, or by contacting the department.
- I can obtain proof of my circumstances/details from the department and provide it to Wentworth Community Housing Ltd so that my eligibility for a rebate/service can be determined.
- If I withdraw my consent or do not alternatively provide proof of my circumstances/details, I may not be eligible for the rebate/service provided by Wentworth Community Housing Ltd.
